THE DEPUTY MINISTER IN THE MINISTRY OF FINANCE (SHRIMATI SUSHILA ROHATGI): (a) Yes. Sir.

(b) The General Insurance vices Integration Committee (Mathrani Committee) submitted in all seven reports which included reports on categorisation of officers for Top, Senior middle management and middle management levels, criteria absorption and guidelines for seniority of officers and other staff in the General Insurance Industry. The recommendations of the Committee pertaining to categorisation of posts, pay scales and other terms and conditions of the supervisory, clerical and subordinate staff as well as officers were laid on the Table of the House in reply to Unstarred Question No. 4815 on 14/12/1973.

(c) Rs. 10,14,949 (subject to audit).

(d) and (e). The Central Government has framed a scheme regarding categorisation of posts, pay scales and other terms and conditions of service of the supervisory, clemeal and subordinate staff, under section 16(1)(g) of the General Insurance Business (Nationalisation) Act, 1972. Scheme was notified in official gazette on 27-5-1974. While in framing the Scheme the recommendations of the Mathrani Committee were kept in view, but after negotiations with the staff it become necessary to modify the Committee's recommendations on certain matters. The framing of a scheme for other employees namely officers and Development staff is under consideration.

Recommendations regarding categorisation of officers were treated as
provisional, pending review by Committee, suo motu or on receipt of representations from affected officers,
Certain changes in the lists of officers
for Top and Senior Middle Management level posts recommended by the
reviewing Committee have been approved by the GIC Board.

Meeting of Indo-Yugoslavia Joint Committee

3621 SHRI M. KATHAMUTHU: Will the Minister of COMMERCE be pleased to state.

- (a) whether there was a meeting of the Indo-Yugoslavia Joint Committee recently; and
- (b) if so, the subjects discussed and the outcome thereof?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI VISHWANATH PRATAP SINGH): (a) and (b). Yes Sir. The ninth sessior of the Indo-Yugaslav Joint Committee was held in New Delhi from February 10th to 15th. 1975. The two sides discussed matters relating to expansion and diversification of trade, industrial cooperation in India, in Yugoslavia and in third countries as well as other issues in the field of mutual economic relations.

Several items having potential in Yugoslav market were identified e.g., automobile ancillaries, tyre and tubes, steel slabs, pig iron ctc. Possibilities for collaboration in the industrial field in India and in Yugoslavia were dis-

cussed. It was felt that there are prospects for joint ventures in third countries specially in consultancy, civil engineering works and in supply of equipment, It was agreed that a Sub-Committee on Banking and Financial Cooperation be set up to consider measures for increasing mutual consultation and cooperation between the respective governments, their Central Banks, Commercial Banks and other financial institutions,
