- (a) the total quantity of fish exported by India in the year 1974-75 and the amount earned therefrom;
- (b) whether there is a downward trend in the demand from abroad for fish from India, and
- (c) if so, the steps taken by Government to improve its demand?

THE DEPUTY MINISTER IN THE MINISTRY OF COMMERCE (SHRI VISHWANATH PRATAP SINGH):

(a) 20 5 thousand tonnes of fish valued at Rs 38 04 crores were exported during April-October 1974 (1974-75).

- (b) While there is a decline in the exports of fish during 1974-75 so far, as compared to the exports in the corresponding period last year due to recession in affluent markets coupled with lower catches of exportable varieties of fish, this has not yet assumed the form of a downward trend in the demand for fish from India
- (c) In order to arrest the decline in exports of fish so far, two sales delegations—one to USA and the other to Japan—were sent in December, 1974.
