of Integrated Urban Development Projects in metropolitan cities and areas of national importance. For the year 1974-75, a sum of Rs. 14.84 crores has been provided.

- (b) The Scheme came into effect from the 1st April, 1974. So far, releases of the following amounts have been sanctioned:-
  - (i) Rs. 7.50 crores to the West Bengal Government as loan programmes of the for the Calcutta Metropolitan Development Authority.
  - (ii) Rs. 2.50 crores to the Maharashtra Government as loan for the programmes of the Bombay Metropolian Region-Development Authority and for the City and Industrial Development Corporation for its project for development of Metro-centre in Bombay
  - (c) Yes, Sir.
- (d) The Government of Tamil Nadu has requested for assistance for their augmentation of water project for supply to the Madras City. The Government are examining the project.

#### Alleged delay in Urdu Panel Report

4575. SHRI VASANT SATHE: Will the Minister of EDUCATION, SO-CIAL WELFARE AND CULTURE be pleased to state

- (a) whether the attention of Government has been drawn to a news report on the 17th February, under the caption 'Urdu Panel delaying report deliberately':
- (b) if so, the reaction of Government to the various observations made therein: and
  - (c) the action taken in the matter?

THE DEPUTY MINISTER IN THE MINISTRY OF EDUCATION AND SOCIAL WELFARE AND IN THE DEPARTMENT OF CULTURE (SHRI D. P. YADAV): (a) Yes Sir.

- (b) and (c). It is not a fact that the report of the Committee for promotion of Urdu is being delayed deliberately. The Committee for promotion of Urdu has held 26 meetings and has examined, along with its Sub-Committees, 350 witnesses and has gathered extensive information opinions from individuals, organisations, universities, newspapers and State Governments. The report of the Committee is expected to be finalised soon. It may be mentioned that the number of members who have died since the Committee was set up is two.
- 2. The only objective in setting up the Committee was to obtain from it advice on the measures to be adopted for the promotion of Urdu language and the steps required to be taken to provide adequate facilities for Urdu speaking people in educational, cultural and administrative matters. It is not a fact that the Committee has been packed with officials; in fact, the number of officials on it has been kept to a bare minimum and representatives from only Ministries have been included in it which are concerned with the terms of reference of the Committee.
- 3. Government have been aware of the problems in the promotion of Urdu in the country and it is as a result of this awareness that the Committee for Promotion of Urdu has been set up,

## World Bank's Assistance for fisheries in Kerala

THE DEPUTY MINISTER IN THE MINISTRY OF AGRICULTURE AND IRRIGATION (SHRI PRABHUDAS PATEL): (a) and (b). The possibility of obtaining financial assistance from the World Bank Group for devolopment of fisheries which might include Kerala State is under consideration. A Reconnaissan Mission had recently visited India and had gone to some States including Kerala, where it visited Vizhinjam, Neendakara, Cochin Beypore, Balapatnam and Cannanore. The Mission was apprised of the need for assistance to develop marine fisheries in an integrated manner including harbour construction. The report of the Mission has not yet become available.

### South Delhi Campus

4577. SHRI SHASHI BHUSHAN: Will the Minister of EDUCATION. SOCIAL WELFARE AND CULTURE be pleased to state:

- (a) whether he has seen a press report appearing in the Hindustan Times dated the 18th January, 1975 to the effect that the South Delhi Campus, conceived as an alternative to a second University in the city, feels ignored by the academic nerve centre situated on the other side of the city and the students of the Second Campus are bitter over their alienation from the main campus; and
- (b) the reaction of Government thereto and the steps taken to improve the situation?

THE MINISTER OF EDUCATION SOCIAL WELFARE AND CULTURE (PROF. S. NURUL HASAN): (a) Yes, Sir.

(b) According to the University of Delhi, the statement is not correct. However, in order to consider the question of the status, functioning and future set up of the South Delhi Campus, the Vice-Chancellor has constituted a Committee which has met twice so far.

# Consideration of Narmada Water Issue by Tribunal
