THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESHWAR PRASAD): (a) and (b), The information is being collected and will be laid on the Table of the House as soon as possible.

Second Mine cut in Neyveli

8106. SHRI THA KIRUTTINAN: Will the Minister of ENERGY be pleased to state:

- (a) whether the Tamil Nadu Government has constantly been stressing the Centre to start the second mine cut in Neyveli;
- (b) if so, the reasons put forward for its urgency: and
- (c) the action taken by Government thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF ENERGY (PROF. SIDDHESHWAR PRASAD): (a) to (c). The Tamil Nadu Government have been pressing for the opening of the second mine cut in Neyveli, keeping in view the advantages of additional power generation based on increased production of Lignite. The project is under the consideration of Central Government.
