Development Works in Vikram Sara-Bhai Space Centre

THE PRIME MINISTER, MINIS-TER OF ATOMIC ENERGY, MIN-ELECTRONICS AND OF ISTER OF SPACE, MINISTER MINISTER OF PLANNING AND MINISTER OF TECHNOLOGY SCIENCE AND (SHRIMATI INDIRA GANDHI): (a) The works included in the Fifth Plan Vikram to be undertaken by the Sarabhai Space Centre include development of satellite launching capability, development of satellites, establishment of facilities for the production of rockets and propellants and expansion of test facilities.

(b) The progress made so far and the steps taken to improve the functions are set out in detail in the Annual Report of the Department of Space for the year 1974-75 and in the Performance Budget for 1975-76, copies of which are available in the Library of Parliament.

Delivery of Letters in Kerala

Action is being taken to introduce mail motor services, wherever feasible, to avoid hold-up of mails. The State Road Transport Corporation has also been approached to agree to carry mails.
