THE PRIME MINISTER, MINISTER OF ATOMIC ENERGY, MINISTER OF ELECTRONICS AND MINISTER OF SPACE, MINISTER OF PLAN-NING AND MINISTER OF SCIENCE TECHNOLOGY (SHRIMATI INDIRA GANDHI): (a) to (c). The Electronics Commission and its executive agency, the Department of Electronics, were set up in February, 1971 with a view to ensuring appropriate formulation and implementation of policies and measures relating to the field of electronics. The responsibilities and functions of the Electronics Commission are reviewed whenever necessary. Government are considering the recommendations, inter alia, of the Estimates Committee of Parliament in this regard.

Sale of Equity Shares of Public Undertakings

It was clarified that the concept of the public participation in Scooters India Ltd., public sector enterprises was not a new concept and was merely aimed at enlisting the actual participation of the common man in public enterprises.
