THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) While the overail law and order situation in the country has generally remained peaceful after the promulgation of Emergency. Government are aware of the underground activities of some extremist and militant groups to disrupt public life. Government have been taking appropriate steps from time to time to deal with them.

(b) and (c). No case of police firing or lathi charge has been reported by the Governments of Tripura, Himachal Pradesh and Sikkim and the Union Territory Administrations of Andaman and Nicobar and Lakshadweep. The information is awaited from other State Governments and Union Lerritory Administrations
