been brought to the notice of the Government.

- (b) Complete information is being collected from the State Governments concerned and will be laid on the table of the Sabha.
- (c) Following security and safety measures already exist in this regard:
- 1. Escorting of important Mail and Express Trains by Government Railway Police;
 - Detailing of plain-cloth Government Railway Police staff on affected Sections;
 - 3. Assistance of Railway Protection Force for escorting duties, when needed:
 - Frequent surprise checks by Government Railway Police supervisory staff;
 - 5. Safety devices in coaches are strengthened where required; and
 - 6. Co-ordination Meetings among Government Railway Police, State Police and Railway Protection Force.

Dieselisation of Meerut Shuttle Trains

1204. SHRI PRABODH CHANDRA: Will the Minister of RAILWAYS be pleased to state:

- (a) whether most of the shuttle trains of Northern Railway have since been dieselized; and
- (b) if so, the reasons for not providing diesel engine to 2 NM and 1 NM Meerut shuttle trains?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) No.

(b) Dieselisation of INM/2NM New Delhi-Meerut City shuttle is at present not feasible due to non-availability of spare diesel engines.

Introduction of Jute Special between Calcutta and Jogbani

1205. SHRI H. N. MUKERJEE; Will the Minister of RAILWAYS be pleased to state:

- (a) whether North-East Frontier Railway has decided to introduce a "Jute Special" between Calcutta and Jogbani; and
- (b) if so, the broad features there-of?

THE DEPUTY MINISTER IN THE MINISTRY OF RAILWAYS (SHRI BUTA SINGH): (a) Yes.

(b) Metre Gauge wagons are supplied for loading jute consignments at Jogbani and moved in block rakes to Katihar where the contents are transhipped into Broad Gauge wagons. After transhipment, the broad gauge wagons are moved as a block rake to Kidderpore Docks. The average transit time from loading at Jogbani to arrival in Kidderpore Docks is about five days.

This scheme has been conceived and brought into effect mainly with a view to provide quick rail transport facilities for Jute exports via Calcutta Port.

Representation regarding supply of Sulphuric Acid from West Bengal

1206. SHRI A. K. KISKU: Will the Minister of CHEMICALS AND FERTILIZERS be pleased to state:

- (a) whether his Ministry has received any representation from the small units in Bengal about the difficulties in getting adequate quantities of sulphuric acid at reasonable prices; and
- (b) if so, the action taken in the matter?

THE MINISTER OF CHEMICALS
AND FERTILIZERS (SHRI P. C.
SETHI): (a) Yes, Sir. The Ministry

had received a representation from the small scale units in West Bengal in this regard

(b) The position was reviewed at a meeting held jointly with the representatives of the manufacturers and the consumers. The manufacturers were advised to make special efforts to meet the sulphuric acid requirements of the small scale units. Even though the sulphuric acid price is not statutorily controlled they were also advised to agree on a price which would be fair to both the parties.
