# Affiliation of Voluntary Organisations with Khadi and Village Industries

THE MINISTER OF STATE IN THE MINISTERY OF INDUSTRY AND CIVIL SUPPLIES (SHRI A P SHAR-MA)· (a) and (b) The development programmes of the Khadı and Village Industries Commission are implemented by two kinds of voluntary agencies, (i) institutions registered under the Societies Registration Act, 1860, and (ii) co-operative registered under the respective State Co-operative Act.

In 1974-75 there were 700 institutions registered under the Societies Registration Act and around 24,000 co-operatives registered under the State Co-operative Acts. There is no institution called the "Association of Voluntary Agencies for Rural Development," on the list of institutions directly assisted by the Khadi and Village Industries Commission is not aware whether any of the above registered institution and co-operatives are affiliated to the "Association of Voluntary Agencies for Rural Development"

- (b) The Conference reviewed the progress of steamlining the administrative arrangements for implementing the Sub-Plan It was agreed that there should be adequate delegation of financial and administrative powers to the Project authorities The personnel policies for tribal areas should also be urgently reviewed
- (c) Expenditure on strengthening and streamlining of administrative structure, in suitable cases, is allowed to be met from Special Central assistance for tribal sub-plans.

### Improvement of Road Under B.R.D.B. **Programme**

727. SHRI BISWANARAYAN SHA-STRI: Will the Minister of DEFENCE be pleased to state:

- whether Government have considered the improvement of the road under B.R.D.B. programme from Silapathar to Sonarighat with construction of permanent bridges; and
- (b) if so, when the work is likely to be completed?

THE MINISTER OF DEFENCE (SHRI BANSI LAL): (a) The road Silapathar to Sonarighat is crossed by a number of rivulets which receive excessive water from the river Brahmputra during floods. Due to the erratic behaviour of river Brahmputra and the non-existence of a well defined river bed, timber pile bridges are considered suitable for crossings this area, Accordingly class 18 timber bridges have been constructed on this road which fully meet the traffic requirements.

(b) In view of the above, there are no plans at present for construction of permanent bridges on this road.

## Two Year Tax Holday for T.V. Industry

THE PRIME MINISTER, MINISTER MINISTER PLANNING, OF ATOMIC ENERGY, MINISTER OF ELECTRONICS AND MINISTER OF SPACE (SHRIMATI INDIRA GAN-DHI): (a) Yes, Sir,

(b) Government have already indicated through a Customs Notification dated February 16, 1976 that the import duty on the glass shells used in the manufacture of TV picture tubes would be reduced with immediate effect from 186 per cent to 75 per cent. According to the Union Budget for 1976-77, the excise duty on TV sets with an ex-factory price of Rs. 1800 and below is reduced to 5 per cent while for sets with an ex-factory price above Rs. 1800 the excise duty remains at 20 per cent ad-valorem. It immediate steps are now taken by industry to design simple, functional TV sets and to reduce their manufacturing and marketing costs in the many areas where this is possible, TV sets should become available to consumers at a considerably lower price than they are today. This would lead, in turn, to an expansion in demand for TV sets and, as a consequence, to growth in TV set production.
