Non-conventional raw material for paper production

THE MINISTER OF STATE IN MINISTRY OF INDUSTRY AND CIVIL SUPPLIES (SHRI B P MAURYA) (a) and (b) Government is planning to set up a Central Reand Development Institute search for filling up the gap in the existing research and development programmes relating to pulp, paper and newsprint industries and coordinating these activities throughout the coun-Identification of non-conventional raw materials for manufacture of paper and newsprint and the development of the process know-how for the utilisation of the various raw materials would be some of the issues with which the Institute would concein itself

In the scheme tentatively worked out for the setting up of the Institute, it is proposed that it would be an autonomous organisation registered under the Societies Act. The riembership of the Institute would be open to all companies/corporate bodies engaged in the manufacture or otherwise interested in the development of paper pulp and newsprint and allied products. The management of the Institute would vest with a Governing Council

A final decision regarding the setting up of this Institute is however, yet to be taken
