### Proposal to Convert the Tribal Research and Training Centre at Kozhikode into an Autonomous Institution

(a) whether Kerala State Government have a proposal under consideration to convert the Tribal Research and Training Centre at Kozhikode into an autonomous institution;

(b) whether the necessary memorandum and articles of association have been submitted to Central Government to get the permission for it; and

(c) broad outlines thereof and Government's decision thereon?

THE DEPUTY MINISTER IN THE MINISTRY OF HOME AFFAIRS (SHRI F. H. MOHSIN): (a) and (b). Yes, Sir.

(c) The proposals relate to:

- (i) converting the Tribal Restarch and Training Centre, Kozhikode into an utonomous body.
- (ii) vesting the Governing Eody with full powers for administration of the Institute subject only to nominal restrictions from the Government.
- (iii) Grant of funds to cover costs of staff and equipment.

The structure of the Tribal Research and Training Centre is to be finally decided by the State Government. The Government of India have agreed to the creation of certain posts as recommended by the Central Research Advisory Council for Kerala Centre.

# Harija,: Houses Burat in Village Palai, District Moradabad, U.P.
