#### STATEMENT

The State Government have earmarked Rs. 96 lakhs for setting up 48 rural industrial estates costing Rs. 2:00 lakhs each at the Headquarters of Panchayat Samiti. Locations of 9 Estates at Jaipur Road, Aska, Sakhigopal, Bhawanipatna, Sambalpur, Rayagada, Talcher, Tikabali and Jatni have been finalized. Selection of sites of the remaining 39 Estates will be finalized soon by the State Government.

- (स) विज्ञापनों ग्रीर विकी से कुल ३,६४,००० रु० की ग्राय हुई है।

- (b) whether it is also a fact that the Dandakaranya Development Authority has requested his Ministry to help it in planning and executing big engineering undertakings;

The Minister of Works, and Supply (Shri Mehr Chang Khanna): (a) to (c). Yes. The matter is now under the active consideration of the Government.

(d) The requirements of funds for the Dandakaranya Project are considered on an year to year basis. The amount likely to be spent during the Third Plan period cannot be estimated at present but in the first year of the Third Five Year Plan the Dandakaranya Project incurred an expenditure of about Rs. 5.07 crores.
