The Deputy Minister of Community Development, Panchayati Raj and Cooperation (Shri Sham Dhar Misra):
(a) and (b). The Minister for Food and Agriculture will lay on the table of the Sabha necessary information as soon as it is available.

(c) No, Sir Government had recently set up a Committee on Cooperative Credit and a Working Group on Co-operative Farming. The reports of the Committee and of the Working Group as well as decisions of Government thereon had already been laid on the table of the Sabha. Steps are now being taken to implement these decisions.
