The Minister of State in the Ministry of Home Affairs (Shri Vidya Charan Shukla): (a) to (c). The Government of India have recently received proposals for the revision of scales of pay of the Manipur Police and Radio Staff on the Assam pat-These proposals are being examined.

Grants to Manipur Schools

1765. Shri M. Meghachandra: Will the Minister of Education be pleased to state:

- (a) whether it is a fact that the Manipur Government have not paid the regularly payable grants to the Government aided elementary schools for the last few months:
 - (b) if so, the reasons therefor:
- (c) whether this has resulted inirregular receipt of pay and the nonreceipt of arrears of pay by the teachers in these schools: and
- (d) the steps taken to pay the grantsin time?

The Minister of State in the Ministry of Education (Shri Bhagwat Jha Azad): (a) to (d). Yes, Sir. There have been delays in the payment of grants during the last few months. which has resulted in irregular payment of salaries to teachers. Grants for March, 1967 have already been paid in many cases. Grants for the period April to August, 1967 as well as for the arrears of pay have been sanctioned and payments will be made after clearance from Accounts authorities. The delays are reported to be mainly due to observance of such procedural requirements as checking of accounts, obtaining utilization certificates, etc. Administration of the Union Territory of Manipur are examining the ways and means of avoiding delays in future.
