- (b) if so, when the discovery of the loss of these papers was made; and
- (c) whether any steps have taken to recover the lost papers?

The Minister of State in the Ministry of Education (Shri Sher Singh): (a) No disappearance of Prime Minister Nehru's papers has been reported or came to notice.

## Strike in Deulbera Colliery

## 1792. Shri K. P. Singh Deo: Shri P. K. Deo:

Will the Minister of Labour and Rehabilitation be pleased to state:

- (a) whether it is a fact that the workers of Deulbera Colliery, Talcher in Dhenkanal District. Orissa have gone on strike since 4th May, 1967;
- (b) whethre an appeal has made by the President of Deulbera Colliery Labour Union for conciliation; and
- (c) if so, the action taken by Govment in this regard?

The Minister of State in the Ministry of Labour, Employment and Rehabilitation (Shri L. N. Mishra): (a) No. But some sand-loading workers of the colliery who were transferred temporarily to Talcher Colliery under the same management continued to work on their own at Deufbera Colliery and demanded wages for such work.

- (b) yes, by a group of the union not recognised.
- (c) No conciliation was held but enquiries were made. A bipartite set lement was reached between the management and the recognised group of the union whereby most workers have resumed duty.
