CALLING ATTENTION TO MATTER: OF URGENT PUBLIC IMPORTANCE:

EXPLOSIONS IN DELHI

Shri Hem Barua (Gauhati): Sir, under Rule 197, I beg to call the attention of the Minister of Home-Affairs to the following matter of urgent public importance and I request that he may make a statement thereon:—

"The two explosions reported to have occurred on 14th and 15th May, 1962 in Delhi."

The Minister of Home Affairs (Shri Lal Bahadur Shastri): Sir, on the 14th May at about 8.15 P.M. an explosion occurred in the Lal Kuan Bazar, Delhi, near the shop of some banglesellers situated in the vicinity of the show-room of the Hamdard Dawa Khana. The Bazar was crowded at the time with people making purchases on the eve of Id-ul-Zuha. It appears that some explosive substance burst inside a bottle near a place where the bangle-sellers were doing their business. Splinters from blast caused two holes in the glass pane in the window of the Khana show room. A man and his family of four children who purchasing bangles received minor injuries while two bangle-sellers and three women suffered from police scratches. The superficial reached the spot of the explosion soon injured after the incident and the persons were immediately taken to-
