## Telephone Exchange at Byawar

1671. Shri Mate: Will the Minister of Transport and Communications be pleased to state:

- (a) whether he had received any application from the public of Byawar, District Chhatarpur for a telephone exchange to be opened there; and
- (b) if so, what action has been taken so far?

The Deputy Minister of Transport and Communications (Shri Bhagavati):
(a) and (b). There has been no demand for a Telephone exchange. Sanction has been issued for opening a Public Call Office. Extensions from the Public Call Office will be provided if any demands for telephone connections come up.

According to the existing procedure for the release of Central assistance to the States, allotment of funds is not made scheme-wise but amount is sanctioned only at the end of each financial year for broad groups categories of schemes. Threefourths of the total Central assistance allocated for a financial year is, however, released in lump sum ways and means advances to the State Governments in nine equal instalments during the course of the year. In view of this position, the question of sanctioning assistance for individual schemes does not arise.
