

(c) if so, the reason for the same;  
 (d) when the work is going to be resumed and the time limit within which it shall be completed;

(e) what is the distance to be covered by the scheme;

(f) whether the distance is going to be measured from the border of the State concerned or from the situation of the sub-Station from which the electricity is to be supplied;

(g) what are the Areas of various Tehsils of the Alwar District that will be covered by the Scheme; and

(h) whether there is any possibility of further extension of these areas?

**The Minister of State in the Ministry of Irrigation and Power (Shri Alagesan):** (a) to (d). A scheme for supplying electricity from the Bhakra Nangal Project to areas of Alwar district of Rajasthan from the adjoining areas of Punjab has been drawn up by the Rajasthan Government. A part of the scheme has been sanctioned and put into operation. The implementation of the remaining part of the scheme will depend upon the availability of funds.

(e) 35 miles.

(f) From the situation of the sub-station from which power is to be supplied.

(g) Tijara and Kot Qasim.

(h) Yes, depending upon the future development programme and the availability of funds.

#### **Onions Produced in Maharashtra and Gujarat**

**1773. Shri Jashvant Mehta:** Will the Minister of Food and Agriculture be pleased to state:

(a) whether it is a fact that large quantities of opinions produced in Maharashtra and Gujarat have remained unsold due to the fall in price;

(b) if so, what is the quantity that has remained unsold;

(c) what steps have been taken by Government to preserve the Onions; and

(d) whether Government propose to give any price support and make railway wagons available for the despatch of onions to countries like Ceylon?

**The Minister of State in the Ministry of Food and Agriculture (Dr. Ram Subhag Singh):** (a) and (b). The information has been called for from the Governments of Maharashtra and Gujarat. The Government of India has no present information in the matter.

(c) Does not arise.

(d) The question of giving price support does not arise. The supply of wagons is governed by the priority of registration and in keeping with the quotas fixed for the particular type of goods from time to time. Onions being a perishable commodity, qualifies for movement in priority class 'D' of the Preferential Traffic Schedule and normally the demands of the trade for moving this traffic are met without much difficulty having regard to the Railway's commitments for movement of higher priority traffic.

(a) the number of physiotherapy units functioning at present in Government hospitals in India, State-wise;

(b) the number of patients treated at these centres during the first four months of 1962;

(d) whether Government intend to set up an All-India School of Physiotherapy to train the Physiotherapists required in our country?
