Aid to Librarians in Andhra Pradesh

The Minister of Education (Dr. K. L. Shrimali): (a) No financial aid was given direct to libraries in the State. The State Plan, however, includes schemes for development of libraries. It is not possible to indicate the Central on these schemes as Central assistance is not allocated scheme-wise.

(b) and (c). 250 copies each of 28 Hindi books were supplied free of cost to the Government of Andhra Pradesh for distribution among school libraries under the scheme of Presentation of Free Gifts of Hindi Books.

Monuments at Nagarjuna Sagar Project

The project would be undertaken by the Government of The proposed Orissa. scheme has been approved by the Government of India. Since the scheme was approved only recently, it is too early expect any progress report. expected that the new factory would commence production during 1965-66.
