if necessary, is also permitted for entry into Government service.

Written Answers

(ii) Ex-servicemen are given Vocational/Technical training in the Institutions run by the State Government/ General of Employment Directorate and Training. The Ministry of Demonthly stipend of fence gives a Rs. 25 - to each ex-serviceman trainee for subsistence during the period of training which varies from 12 to 24 months.

Pakistanis in Assam

1865. Shri P. C. Borooah: Will the Minister of Home Affairs be pleased to state:

- (a) whether it is a fact that Assam Government have recently served a large number of Pakistanis with "Quit India" notice from North Lakhimpur, Nowgong and Sibsagar districts of Assam;

- (c) whether some Pakistanis in possession of forged visas have also been arrested in Assam; and
 - (d) if so, how many?

Voting in Puniab

- (c) the number of persons who lost their deposits. Party-wise?

The Minister of Law (Shri A. K. Sen): (a) The percentage of voters who cast their votes in the General Elections from the State of Punjab was 65.45 and 56.39 to the Lok Sabha and the State Legislative Assembly respectively.

Book-Grants to Tribal Students of Tripura

(b) and (c). The monthly income of the parent is duly taken into consideration but no maximum limit has been prescribed.
