Lime-Stone in Alwar

1869. Shri K. R. Gupta: Will the Minister of Mines and Fuel be pleased to state:

- (a) whether any survey of limestone for cement manufacture has been taken up in Rajgarh and Thana Gazi Tehsils of District Alwar (Rajasthan):
 - (b) if so, the result thereof; and
- (c) if the reply to part (a) above be in the negative, whether Government contemplated to take up the survey in the near future or they are going to advise the State Government to take up the same?

The Deputy-Minister in the Ministry of Mines and Fuel (Shri Hajar-Bavis): (a) and (b). Yes, Sir. Most of the limestone from Rajgarh area would not be suifable for the manufacture of cement. The tuffaceous limestone near Ghatra is low in magnesia and is suitable for the manufacture of cement. The reserves of this tuffaceous limestone are of the order of 250,000 tonnes.

(c) Does not arise.

Coal for Industries

- (a) whether the decision of Government to the effect that no industry would get less coal than what it was actually getting before the cut in the movement of coal was decided, has been communicated to the State Government of U.P.; and

The Minister of Mines and Fuel (Shri K. D. Malaviya): (a) Yes. Revised allocations have been determined on the basis of actual availability of rail transport while ensuring that the quotas so fixed for the various States do not fall below last year's despatches.
