## Panna Diamond Mines

1887, Shrimati Maimoona Sultan: Will the Minister of Mines and Fuel be pleased to state:

- (a) whether a number of schemes for the exploitation of the Panna Diamond Mines have been sanctioned; and
- (b) the progress so far achieved in the implementation of the schemes?

The Deputy Minister in the Ministry of Mines and Fuel Hajarnavis): (a) and (b). The Panna Diamond Project has been entrusted to the National Mineral Development Corporation for implementation and will consist of a number of individual Already, the Project Report for the Ramkherya Mine, with a target output of 12,500 carats per annum has been sanctioned, as well as the Project Report for the Majhgawan Mine, with a target output of 30,000 carats per annum. These mines are expected to commence production within 1963. It is also intended to introduce later a second shift in the Majhgawan Mine, for an additional output of 30,000 carats per year. Question of opening of a third mine will also be considered as part of the phased programme.

## Colleges for Training of Teachers

- 1888. Shri Krishnapal Singh: Will the Minister of Education be pleased to state:
- (a) whether the Ministry proposes to start four regional colleges for training teachers in specialised subjects:
- (b) what is the financial provision meant for the purpose;
- (c) whether the Universities have been consulted whether they could have run the courses with necessary financial aid:
- (d) why it is that slected existing colleges cannot be developed and improved to serve the same purpose with much less cost:
- (e) what is the per capita recurring expenditure on training of teachers in the Central Institute of Education, Delhi in colleges affiliated to different Universities and in the proposed colleges; and
- (f) what is the per capita capital expenditure for these institutions compared with a out 15 selected institutions one in each State?

The Minister of Education (Dr. K. L. Shrimali): (a). Yes. The Four Regional Colleges will train teachers for multi-purpose Secondary schools.

- (b) Rs. 3.32 crores during the Third Five Year Plan.
- (c) and (d). State Governments had been consulted, but not the Universities. Consultations with the State Governments confirmed the view that for the special kind of training required for multipurpose schools, it was not University departments of Education.
- (e). Per capita expenditure in the Central Institute of Education is

necessary first-aid.

Rs. 2,600. Information about other colleges affiliated to different versities is not available. capita recurring expenditure in the proposed colleges is estimated Rs. 2,150.

(f). Government have no information of the 15institutions mentioned in this part of the question, but it may be mentioned that since the types of training differ, the two kinds of institutions cannot be considered comparable

RAILWAY ACCIDENT AT SEALDAH ON 22ND MAY 1962

The Deputy Minister in the Ministry of Railways (Shri Shahnawar Khan): In reference to the Attention Notice received from certain Members in connection with the above accident. I have to inform the House that while S. 188 Dn. Dankuni-Sealdah Local Passenger was entering No. 1 Platform at Sealdah North Station at 9.52 hours on 22-5-1962, it dashed against the dead-end causing injuries to 41 persons. Of these 17 were railway employees and the remaining 24, passengers. Firstaid was promptly administered to the injured persons at the Railway Station. The Divisional Medical Officer, Sealdah, reached the site immediately after the accident to supervise medical aid to the injured

Four railway employees and passenger were admitted in the B. R. Singh Railway Hospital and woman passenger was admitted in the N. R. Sarkar Hospital. The remaining 35 persons were discharged after

According to the authorities of the two hospitals where the six injured persons were admitted, all the six received simple injuries.

A Divisional Officers' enquiry has been ordered to investigate the cause of the accident.

चार रेलवे कर्मचारी भौर एक यात्री बी॰ म्रार॰ सिंह रेलवे हास्पिटल में मौर एक महिला यात्री एन० ग्रार० हास्पिटल में दाखिल किये गये। बाकी के ३५ मादिमयौँ को मामली मरहम-पट्टी करने के बाद हिस्चार्ज कर दिया गया।
