Atomic Power Station in Andhra Pradesh

However, a Site Selection Committee set up by the Department of Atomic Energy in 1952 selected three sites for future atomic power stations, including Somasila near Srisilam in Andhra Pradesh. In

reply to enquiries received from the Government of Andhra Pradesh, that Government has been informed that there is no proposal at present to set up an atomic power station in Andhra Pradesh.
