**The Minister of Industry in the Ministry of Commerce and Industry (Shri Kanungo):** The production of salt during 1961 was 34.8 lakh tonnes. During 1962, up to the end of August, the production has been 34.6 lakh tonnes. The total requirements of salt during 1962-63 for edible and industrial purposes and for exports is estimated at about 37 lakh tonnes.
