Streptomycin Plant in Pimpri

The Minister of Industry in the Ministry of Commerce and Industry (Shri Kanungo): (a) The original rough estimate was Rs. 1,70,10,000.

- (b) Yes; the revised estimate stands at Rs. 2,10,30,000.
- (c) The revised estimate exceeds the original rough estimate by Rs. 40,20,000 mainly due to the following reasons:
 - (i) The ratio of production of Streptomycin and Dihydrostreptomycin was changed from the original ratio of 20:80 to 50:50 respectively to be in conformity with the estimated requirements of these two types of drugs and this involved provision for additional equipment.
 - (ii) In the light of the latest technological developments provision for certain additional equipment had also to be

made in order to improve the quality of the streptomycin to be produced.

(iii) The revised estimates had been calcutated on the basis of quotations received in response to global tenders and the placement of final contracts for equipment, etc.
