Cargo Handling at Calcutta Docks

3876, Shri Sidheshwar Praead: Shri Sitaram Keuri: Shri Shashi Ranjan:

Will the Minister of Labour and Rehabilitation be pleased to state:

- (a) the steps Government propose to take to improve the low output in cargo handling in Calcutta Docks; and
- (b) the reasons for not filling the vacancies of more than 2000 workers in the gangs of registered labour by taking back the recently retrenched stitches and beggars?

The Minister of Labour and Rehabilitation (Shri Hathi): (a) Two Incentive Tonnage Schemes—one for foodgrains handling and the other for galt ships were introduced with effect from the 16th March, 1965. Further Incentive Tonnage Schemes covering handling of other cargoes are under consideration.

(b) The existing vacancies are 908 and not 2000. The Calcutta Board has since taken a decision to fill up 705 of these vacancies by transferring the existing 60 rollias of Sub-Reserve Pool and 645 temporary registered rollias after confirming them. Further, a

pool of 700 workers is being created by recruiting them as temporarily listed beggars who will work as beggars when there is a rush of good ships; otherwise, they will also work as rollias.
