- (b) The extent to which these mutants could help in augmenting agricultural production can be known only after all the critical tests are completed.
- (c) Apart from the breeding of improved varieties with radiations, atomic energy is used in insect sterilization, pest control and disinfestation of foodgrains and for the preservation of foodgrain, fruit, fish and other food stuffs.

RECRUITMENT OF SCHEDULED CASTES

- (a) whether it is a fact that direct recruitment to Defence Services is made through the annual examinations conducted by the Union Public Service Commission;
- (b) whether it is also a fact that out of at least eight thousand boys who were recommended by the Commission for appointment to the Defence Services as Cadet during the last 15 years, only 14/15 Scheduled Castes and Scheduled Tribes boys were recommended for such appointment; and
- (c) if so, the reason for the low percentage in direct recruitment and appointments to Armed Forces of the Scheduled Castes and Scheduled Tribes?

THE DEFENCE MINISTER (SHRI SWARAN SINGH): (a) Recruitment of Commissioned Officers to the Armed Forces is made through examinations conducted by the Union Public Service Commission followed by interviews held by Services Selection Boards in the case of some entries and through interviews
