

(b) Minor maintenance of fans was undertaken by departmental labour; but no work on a comprehensive scale, as in the present case, was carried out previously.

(c) Owing to its magnitude, the work could not be carried out through the normal departmental labour and was, therefore, executed through the agency of contractors.

Thermal Power Station at Palana (Rajasthan)

441. **Shri Karni Singh Ji:** Will the Minister of Planning be pleased to state whether the Thermal Power Station which was originally planned to be installed at Palana in Rajasthan is now to be built with American loan at Satpura in Madhya Pradesh?

The Deputy Minister of Labour and Employment and for Planning (Shri C. R. Pattabhi Raman): No, Sir. The proposed Thermal Power Station at Palana was not included in the final Plan.

Foreign Experts on Plan Projects

443. **Shri D. D. Puri:** Will the Minister of Planning be pleased to state:

(a) whether foreign experts are being invited to go into the progress or otherwise of various Plan projects now in operation;

(b) if so, the countries from which the experts are being drawn; and

(c) the specific fields and/or projects which the team of experts is required to examine?

The Deputy Minister in the Ministry of Labour and Employment and for Planning (Shri C. R. Pattabhi Raman): (a) to (c). The Planning Commission is engaged in a study of fifteen projects in the public sector in the field of Industry, Minerals, Power and Transport with a view to evolving suitable systems for programming, scheduling, reporting and planning of materials. In connection with this study, it is hoped to avail of the assistance for short periods of a few specialists from the United States where considerable progress in developing management and control techniques has been made in recent years.
