The Minister of State in the Ministry of Food and Agriculture (Dr. Ram Subhag Singh): (a) to (c). No. The scheme for "Exchange of Farmers" tentatively drawn up by the Ministry of Community Development and Cooperation envisages the exchange of young and enthusiastic farmers from

one area to another within the State, or from one State to the other, for short periods to get them acquainted with better agricultural techniques and practices from the experienced agriculturists, progressive farmers etc. Permanent settlement of these farmers was never contemplated. This scheme too has been deferred in view of the National Emergency.
