Will the Minister of RAILWAYS be pleased to state:

(a) whether the Railway Services (Conduct) Rules, 1966 have been amended to prohibit railway employies from publishing books, participating in radio broadcasts or writing letters to newspapers or periodicals;

(b) whether this amendment is not an infringement of the right to freedom of speech and expression granted to citizens by the Constitution; and

(c) if so, the action proposed to be taken to withdraw the same?

THE MINISTER OF RAILWAYS (SHRI C. M. POONACHA): (a) No. Sir. Teh Conduct Rules provide that a railway servant should obtain prior sauction of the Government or the competent authority before publishing books, participating in radio broadcasts or writting letters to newspapers or periodicals except in certain circumstances as mentioned therein. The said rules do not prohibit a railway servant from doing so.
