THE MINISTER OF STATE THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): The unauthorised (a) and (b). Patel, Janta squatttrs of Rondhawa markets numbering about 145, 70 and 68 respectively were removed by the Chandigarh Administration after the notices given to them under Section 173 of the Punjab Municipal Act, 1911. The squatters complied with the notice and vacated. the site. After the site had been. cleared by the encroachers a bulldozer was used to level the ground to make it fit for further use.

U.G.C. Grades of Pay to Teachers of Privately Managed Schools/Colleges
