Amentities for Travelling Troops

- (b) if so, the steps being taken to provide at an early date the necessary accommodation and facilities with the cooperation of the Railway authorities?

The Minister of Defence (Shri Y. B. Chavan): (a) and (b). Some facilities for rest, washing and canteen services for troops in transit exist at Howrah Railway Station. These are being reviewed and Railways have agreed to provide additional facilities to the extent feasible.
