(a) whether the agreement for a loan of \$27 million for the construction of a Fertilizer Factory, at Vishakhapatnam with the U.S. Export Import Bank has been completed; and

(b) if so, when the factory is likely to go into production?

The Minister of State in the Ministry of Petroleum and Chemicals (Shri Alagesan): (a) The US Eximbank has approved the loan but the agreement has not yet been signed.

(b) According to the time schedule submitted by the licensee, the factory is expected to go into production by October, 1966.

The Minister of Petroleum and Chemicals (Shri Humayun Kabir):

(a) About 200 acres of land have been secured and site testing has been completed. Import licences for construction equipment have been received and for refinery equipment are being processed. Access roads are nearing completion and rail connections are being undertaken.
