

Malaysia's inclusion in Security Council

Will the Minister of External Affairs be pleased to state:

(a) whether it is a fact that there was a process of pulse-taking at the U.N. in order to decide the question of Malaysia's inclusion in the Security Council as a non-permanent member;

(b) if so, whether India's opinion was sought for in this connection; and

(c) the stand taken by India on the question?

The Minister of External Affairs (Shri Swaran Singh): (a) The U.N. General Assembly, at its current session, had decided to take up only such of its business as could be transacted without formal voting. In accordance with this decision, consultations were held in order to fill the vacancies in the Security Council. As a result of these consultations, the President declared, and the General Assembly agreed without objection, that Malaysia had become a Member of the Security Council to serve for a period of one year from January, 1965.

(b) India also participated in the above arrangements by which Malaysia became a member of the Security Council.

(c) India supported the candidature of Malaysia.

Rehabilitation of Tibetan Refugees

Will the Minister of External Affairs

be pleased to state:

(a) the number of Tibetan refugees who have not so far been rehabilitated; and

(b) the present programme of their rehabilitation?

The Minister of External Affairs (Shri Swaran Singh): (a) Approximately 30,000. Out of whom nearly 15,000 are gainfully employed temporarily on road works. 2,000 are monks and 1,500 are aged and infirm. Besides, there are batches of small groups of different sects who are trying to be self-supporting on their own partly at times with the help of the Government.

(b) It is proposed to set up two more agricultural settlements for these refugees in addition to the five already in existence.

The Government of India are also actively examining the possibilities of establishing a few small scale industries to further the cause of Tibetan settlement and the State Governments have also been approached in this behalf.

(a) whether the call given by the Prime Minister for a global move to put and end to nuclear terror has yielded any result; and

(b) if so, the broad outlines thereof?

The Minister of External Affairs (Shri Swaran Singh): (a) and (b). The Prime Minister in a message broadcast on December 31, 1964, on the eve of the International Cooperation Year called for "the united effort of all to rid the world of the
