GUIRAL) : The P and T Department has been issuing special stamps in honour of personalities and leaders in different fields regularly. Of the names mentioned in the question, special postage stamps in honour of the following personalities have already been issued on the dates noted against each :

- Maharaja Ranjt Singh

on 28-6-66.
