#### DURGAPUR STEEL PLANT

4329. SHRI BABURAO PATEL: Will the Minister of STEEL, MINES AND METALS be pleased to state:

- (a) the cost likely to be incurred on the 7 man team of British experts arriving soon in India at his request to study Durgapur Steel Plant;
- (b) why a team of foreign experts was considered necessary when Shri A. N. Banerji, Deputy Chairman of the Hindustan Steel, Ltd. said recently: "Durgapur Steel Plant is no longer a sick child. It is becoming healther at a fast rate"; and
- (c) whether there are no Indian experts to give advice and guidance on the working of the steel plants?

THE MINISTER OF STEEL, MINES AND METALS (DR. CHANNA REDDY):
(a) In regard to the British Steel Corporation team which visited Durgapur in February 1968, the expenditure on travel to India and back and the salaries of the experts were borne by the Government of U.K. under the Colombo Plan. The experts were treated as guests of Hindustan Steel Limited and the amount spent during

- their stay in India was approximately: Rs. 6,700/-.
- (b) the Team was entrusted with the work of appraising the equipment and technical assistance requirements of Durgapur to be provided from the United Kingdom, which support is considered necessary in order to hasten the recovery of the Plant.
- (c) Maximum advantage is being taken of available Indian expertise in placing the working of the Plant on an even keel. In view, however, of the fact that our resources of specialist personnel are fully stretched in the Context of organising production of expanded plants as well as the Alloy Steel Plant on an efficient basis, it is considered that selective support from the United Kingdom by way of equipment and technical assistance requirements, is indispensable to ensure rapid recovery at the Durgapur Steel Plant.
