The Minister of Rehabilitation (Shri Tyagi): (a) No. There is road to Pakhanjore and there are link roads to villages. During the monsoon, arrangements are made for crossing the intervening rivers and nalas by ferries.

(b) Does not arise.

(c) The design and estimates for a bridge over the Kotri are under examination. Technical sanction is expected to be issued shortly and the work will be commenced thereafter.

Amenities in Pakhanjore area of Dandakaranya

2623. Shrimati Renu Chakravarty: Will the Minister of Rehabilitation be pleased to state:

(a) whether it is a fact that thousands of displaced persons have been sent to Pakhanjore area in Dandakaranya;

(b) whether amenities like Post Office and high schools have not yet been provided there; and

(c) if so, the steps being taken to provide these amenities?

The Minister of Rehabilitation (Shri Tyagi): (a) 2,595 families have been sent to village sites in the Paralkote Zone, of which the Zonal headquarters, is Pakhanjore.

(b) The Zone has already been provided with 45 primary schools, 2 middle schools, 8 adult schools, 10 community centres, 3 primary health centres, 1 mobile medical unit and 1 post office and 1 sub-post office. High School classes are at present held in the Middle School building. A building for the high school is also under construction.
