#### Fire Fighting Training in Delhi

**The Deputy Minister in the Ministry of Home Affairs (Shri L. N. Mishra):** (a)

i. Fire Fighting.	12,525
ii. First Aid	14,152
iii. Home Nursing	1,745.

(b) 18 training centres have been organised with a capacity to train 400 Civil Defence volunteers per month. The training includes elementary fire-fighting. In addition, 30 First Aid training centres with a capacity of 25 to 30 trainees per centre are functioning.
