The Deputy Minister in the Ministry of Home Affair, (Shri L. N. Mishra): (a) No, Sir. Recruitment to the grade of Lower Division Clerks in the Central Secretariat Clerical Service is made on the results of the competitive examinations held by the Union Public Service Commission. Seven such examinations have so far been held by the Union Public Service Commission since 1958. The number of candidates who applied for these examinations and the number who actually appeared during the
