These were sent to the State Governments concerned for enquiry.

(d) Day to day administration of the Employment Exchanges vests with State Governments to whom complaints are forwarded for appropriate action. During 1966 and 1967 reports were received from State Governments after investigation in 205 cases.

THE MINISTER OF LABOUR AND REHABILITATION (SHRI HATHI): (a) As on 30th November, 1967, the total number of subscribers was 50.87 lakhs and a sum of Rs. 1,048.36 crores was received as contributions upto that date.

- (b) As on 30th November, 1967, the total investments amounted to Rs. 710.65 crores. The investments were made in Central Government securities. Fixed Deposits, Post Office Savings Certificates and State Government securities. etc. and the yield from these investments varies from 2½% to 7% per annum.
- (c) The expenditure on the administration of the Scheme is met from a

special levy realised from the employers at the following rates:—

 (i) 0.37% of the pay of the workers in unexempted establishments; and

- (d) Yes.
- (e) The major losses due to misappropriation amounted to Rs. 16,787.34.
