APPROACH ROADS TO GHATS ON THE GANGES IN BIHAR

3327. SHRI YAMUNA PRASAD MANDAL: Will the Minister of TRA-NSPORT AND SHIPPING be pleased to state:

- (a) whether provision has been made for the construction of approach roads to several ghats on the Ganga in Sarna, Muzaffarpur, Darbranga, Patna, Monghyr, Ehagalpur, Purnea and other places in Bihar State; and
- (b) if so, the progress made in each case?

THE DEPUTY MINISTER IN THE MINISTRY OF TRANSPORT AND SHIPPING (SHRI BHAKT DARSHAN):

(a) and (b). The necessary information is being collected from the State Government and will be laid on the Table of the Sabba in due course.

KORI AND GANDAK AS NATIONAL WATER-WAYS

3328. SHRI YAMUNA PRASAD MANDAL: Will the Minister of TRANSPORT AND SHIPPING be pleased to state:

 (a) whether it is proposed to carry out hydrographic studies of the Kosi for developing the inland water transport; (b) whether Government propose to enact a law to declare the Kosi and the Gandak as National waterways so that the executive responsibility for the development of these waterways and navigation does not devolve on the Government of Bihar?

THE MINISTER OF TRANSPORT AND SHIPPING (DR. V. K. R. V. RAO): (a) and (b). At present, there are no such proposals under the consideration of the Government of India,

COMMERCIAL TRANSPORT SERVICE IN GANGA

3329. SHRI YAMUNA PRASAD MANDAL: Will the Minister of TRANSPORT AND SHIPPING be pleased to state:

- (a) whether the traffic study of the Ganga from Rajmahal to Allahabad, to explore the possibility of running commercial transport service in the Ganga has been completed; and
 - (b) if so, with what results?

THE MINISTER OF TRANSPORT AND SHIPPING (DR. V. K. R. V. RAO): (a) and (b). On the basis of a preliminary study of the assessment of the traffic potential between Allahabad and Rajmahal, the feasibility of running commercial service on the river Ganga on the above reach was examined in consultation with the State Governments of Bihar and Uttar Pradesh. The State Governments are of the view that the scheme will run into losses in the initial stages. The matter is, therefore, being re-examined.

MURDERS IN DELHI

3330. SHRI NARENDRA KUMAR SALVE: Will the Minister of HOMB AFFAIRS be pleased to state:

- (a) the number of suicides and murders registered with the Police Stations in the Union Territory of Delhi during the period from January to June, 1968;
- (b) the number of such cases solved or disposed of by the police in accordance with the law;
- (c) the number of undisposed cases pending with the Police Stations; and

(d) the number of convictions obtained by the Delhi Police in cases involving murder?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): •(a) 42 cases of murder were reported in the Union Territory if Delhi during the period 1-1-1968 to 30-6-1968. During the same period 82 deaths reported were classified as 'suicides'.

(b) to (d) Of 42 cases of murder reported, 5 are pending trial, 33 are pending investigation and 3 have been sent up as untraced so far. One case was cancelled.

LT. GOVERNOR IN DELHI

- 3331. SHRI NARENDRA KUMAR SALVE: Will the Minister of HOME AFFAIRS be pleased to state:
- (a) whether it is a fact that the Lt. Governor of Delhi has sought premature retirement from service; and
 - (b) if so, the reasons therefor?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) Yes Sir. The Lt. Governor of Delhi sought premature retirement from the I.C.S. but not from the office of Lt. Governorship of Delhi.

(b) No reasons for this request were given by him.

U.P. GOVERNMENT EMPLOYEES

3332. SHRI S. M. BANERJEE: Will the Minister of HOME AFFAIRS be pleased to state:

- (a) whether the Advisory Council of U.P. has recommended retinstatement of all the Government employees dismissed or removed from service for taking part in the strike by employees of the U.P. Government;
- (b) if so, the reasons for not implemeting this recommendation; and
- (c) when a final decision is likely to be taken thereon?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) No, Sir.

गृह-कार्य मंत्रालय में राज्य मंत्री (बी विद्याचरण शुक्त): (क) और (ख): सन् 1968 के प्रथम छः महीनों में दिल्ली में कानून तथा व्यवस्था / अपराधिक स्थिति नियंत्रण में रही है तथा 1967 वीं इसी अविध से तुलना से पता चलता है कि सूचित किये गये अपराधों की कुल संख्या में कमी हुई है। संचार के बेहतर साधनों तथा जांच के वैज्ञानिक सहायकों द्वारा दिल्ली पुलिस के आधुनिकीकरण की कई योजनाएं अभी हाल में स्वीकार करसी गई हैं और उन्हें कार्यन्तित किया या रहा है। इससे दिल्ली पुलिस की परिचानन दक्षता में और आणे सुधार होगा।
