Will the Minister of Transport. Aviation. Shipping and Tourism be pleased to state:

- (a) the up-to-date progress made for the construction of a road bridge at Kolaghat on the Rupnarain river on National Highway No. 6;
- (b) whether it will be completed by 1966; and
- (c) the progress of work, yearwise since the decision was taken and tender was accepted?

The Minister of Transport, Aviation, Shipping and Tourism (Shri Sanjiva Reddy): (a) The progress on the construction of the Rupnarain Bridge at Kolaghat on National Highway No. 6 is 67 per cent (upto 15th March, 1966).

- (b) All the beams of the superstructure are expected to be launched by December, 1966 and the bridge made traffic worthy by the end of December, 1966.
- (c) The tender for the work was accepted in May 1961. The contractors started work physically only in February, 1962 but the intervening period was utilised for the collection of materials and machinery and the preparation of drawings and designs. The year-wise progress since the physical start of the work is given helow:
