available as the State Governments are concerned with the establishment and regulation of ferries. However, the ship-building yards in the country have adequate capacity to build such vessels.

Settlement of Ex Servicemen in Tripura

(a) the further progress made so far in selecting and setting the ex-servicemen in Tripura and whether one of the principal reasons is the security of the border areas?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) to (c). A statement containing the requisite information is laid on the Table of the House.

Written Answers STATEMENT

The position, as ascertained from the Government of Tripura, is as under:

- (a) Applications from another 445 exservicemen have since been received. Before such applicants are resettled it is necessary to verify whether they have not already been allotted land or given other benefits under other settlement Schemes. So far, applications of 372 persons have been varified and 53 of them have been found fit for resettlement.
- (b) The ex-servicemen of Tripura already salected for resettlement (56 in number) have been given grants amount to Rs. 26, 400 and they are being given loans to the tune of Rs. 1,23,600.
- (c) The scheme is meant as a measure of resettlement of ex-servicemen and also to improve the morale of the population residing on the border.

Road Development in Tripura

Control of Certain Ancient Places in Tamilnad

SHRI MURASOLI MARAN: 3516. Will the Minister of EDUCATION be pleased to state:

- (a) whether the Union Government received requests from the Tamilnad Government for the control of certain ancient places which are now in the hands of the Central Archaeological Department :
 - (b) if so, the details thereof:
- (c) the reasons assigned by the Tamilnad Government for the same; and
- (d) the reaction of the Union Government thereto?

THE MINISTER OF STATE IN THE MINISTRY OF EDUCATION SHER SINGH): (a) Yes, Sir.

- (b) The State Government had asked for the transfer of (i) Sri Jalakantesvara temple, Vellore Fort, (ii) the Brahadesvara Swami temple at Thanjavur and (iii) such other temples in the State which are Centrally protected and are under worship.
- (c) The State Government which has set up its Department of Archaeology wanted to take over the said monuments for renovation and preservation. In so far as Jalakantesvara temple, which is not in worship, is concerned, the main aim in asking for the transfer of its control seems to be to instal an idol and revive worship.
- (d) The transfer of 59 Centrally protected monuments in the Madras State is under consideration. In so far as the Jalakanteswara Temple and the Brahadeswara Swami temple are concerned, this Ministry has not agreed to their transfer to the State Governments as they are monuments of national importance.
