Will the Minister of HOME AFFAIRS be pleased to state:

(a) whether any information has been received from the Government of Andhra Pradesh that a Harijan was axed to death

- on the Gandhi Jayanti Day on the 2nd October, 1968 at Kanchekacherla, Andhra Pradesh:
- (b) if so, whether the same persons who were responsible for burning a small boy, are connected with this murder; and
- (c) the steps taken by the Central Government in the matter?

THE MINISTER OF STATE IN THE MINISTRY OF HOME AFFAIRS (SHRI VIDYA CHARAN SHUKLA): (a) According to the information received from the State Government a Harijan boy was axed to death on 2nd October, 1968 in village Kanchikacherla in district Krishna in Andhra Pradesh by nine other Harijans due to enmity.

- (b) No, Sir.
- (c) Case for murder was registered. Three of the accused persons were arrested. Five others surrendered in the court. Efforts are being made to apprehend the remaining one accused. Investigation of the case is in progress.
