Educational Institutes in Rural and Urban Areas

- 1026. Dr. Mahadeva Prasad: Will the Minister of Education be pleased to state:
- (a) whether his attention had been drawn to the fact revealed by the All-India Educational Survey (1957-59), viz., important gaps in the distribution of educational institutions between rural and urban population; and
- (b) if so, the manner and the extent by which the aforesald gaps have been filled up?

The Minister of Education (Shri M. C. Chagla): (a) Yes, Sir.

(b) The targets for primary, middle and secondary institutions suggested in the Survey Report have already been exceeded, and the overall situation in the rural areas has become more favourable. The proportions of

educational institutions at the primary, middle and secondary levels in the rural areas in 1958-59 and 1961-62 are given below:

Basic Education

- 1027. Dr. Mahadeva Prasad: Will the Minister of Education be pleased to state:
- (a) whether all the elementary schools were desired to be oriented to the basic pattern during the Third-Five Year Plan; and
- (b) if so, how far this objective has been achieved?

The Deputy Minister in the Ministry of Education (Shrimati Soundarams Ramachandaran): (a) Yes, Sir.

(b) No statistics are collected regarding schools oriented to the basic pattern since the programme includes only introduction of a suitable common syllabus, simple crafts and other activities like social service, community living etc. not involving much expenditure. However, in so far as basic schools are concerned, in 1963-64 there were 83414 Junior Basic Schools out of a total of 3,76,619 Primary Schools and 17,085 Senior Basic Schools out of a total of 65,655 Middle Schools.

Government, in order to ensure that whatever is necessary and possible is done in this behalf.
