The delivery schedules for supply of equipment for the Bokaro Steel Plant by the Heavy Engineering Corporation and the Mining Allied Machinery Corporation Ltd., have only recently been finalised in consultation with the Bokaro Authorities. Every effort will be made to ensure that the equipment is supplied in

accordance with the delivery schedules ogreed to.

According to the existing procedure Central Assistance is sanctioned to the State Government at the end of each financial year on the basis of actual expenditure for the first three quarters and anticipated expenditure for the Fourth quarter. The quantum of Central Assistance for the 4th Plan period as a whole has not been determined.

Machine Tools Ltd., are working to their full installed capacity;

- (b) if so, the annual profit earned during the years 1966-67, 1967-68 and the percentage of the total capital outlay it represents; and
- (c) if any loss has been incurred, the steps being taken to make the Company a profitable concern?

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI F. A. AHMED): (a) The installed capacity of the Hindustan Machine Tools watch factory is being fully utilised, whereas only about 50% of the total installed capacity of the machine tool units of Hindustan Machine Tools Limited is being utilised at present.

- (b) The profit earned during 1966-67 was Rs. 126.3 lakhs representing 3.6 per cent of the capital employed. During 1967-68, there was a loss of Rs. 65.96 lakhs.
- (c) Against the background of steep fall in the demand for machine tools during the last 2 years or so, concerted efforts are being made by the Company to utilise the available manufacturing capacity more fully by diversifying their product range so that the types of sophisticated machine tools which are hitherto being imported could be manufactured them. The Company have also been concentrating on an export drive. They have opened sales-cum-service centres at Frankfurt, New York, Los Angeles and Melbourne and also entered into agency agreements with firms in Sweden, West Germany, Denmark, East European Countries, Benelux Countries, U.K., Canada and Ceylon. The Company are also taking steps to take up production of Heavy Duty Presses, Printing Machinery and L. P. Gas Cylinders. It is expected that the cumulative effect of all these steps will be to make the operations of the Company profitable within a reasonable period.
