Various measures of diversification are under contemplation and they include manufacture of spare parts and components for steel plants, some defence requirements, manufacture of irrigation well drilling rigs, casting machines etc. and obtaining know-how for manufacture of pelletisation plants.

The present orders on the H.M.B.P. are likely to be completed by the end of 1970-71. The order position in the H.M.B.P. & F.F.P. is inter-related. The future magnitude of output in H.E.C. will depend on the additional programme for steel production and the implementation of measures for diversification.

Profitability in this plant during the next five years would largely depend on

the extent of orders for steel and metallurgical equipment during the next few years. The position in this regard is still under examination and would depend on the final sectoral investments in the Fourth Plan.

*Mining and Allied Machinery Corporation*

The actual production in M.A.M.C. has been 3989 tonnes in 1965-66, 4536 tonnes in 1966-67, 5076 tonnes in 1967-68 and 3071—7 tonnes in 1968-69 (April to December, 1968).

Important items of diversification under contemplation include manufacture of coal washeries equipment, mechanical handling plants for ports, hydraulic pit props, agricultural tractors and certain types of earthmoving equipment.

The present orders on M.A.M.C. will be executed by 1970-71. Apart from taking up measures for diversification the Corporation is also maintaining close contact with the coal industry to secure orders.

The profitability of the plant in the next five years will depend on a number of factors including the final sectoral investments in the Fourth Plan, the expansion of the coal industry and the measures of diversification carried out by the M.A.M.C.

*National Small Industries Corporation*

THE MINISTER OF INDUSTRIAL DEVELOPMENT, INTERNAL TRADE AND COMPANY AFFAIRS (SHRI F. A. AHMED) : (a) The National Small Industries Corporation does not have branches in all the States, but assistance is given to small scale industries in all the States.

(b) The Corporation has its Head Office at Delhi and Regional Offices at Calcutta, Madras and Bombay. Through these Offices it is able to cater to the needs of small scale industries in the entire country.

(c) The Corporation has no plans to open new branches in 1969-70. The total value of machines supplied on hire purchase basis to small scale industries in different States is given in the statement laid on the Table of the House. [Placed in Library. See No. LT—210/69].
