- (c) Before admissions are made. certain minimum essential physical facilities such as instructional buildings, equipment, and hostels for students have to be provided and proper staff recruited. This is expected to take about two years.

## Telephones for Mysore

- 1547. Shri H. C. Linga Reddy: Will the Minister of Communications be pleased to state:
- (a) the telephone requirements of Mysore State every year;
- (b) the number of public and private phones given to Mysore State during the Third Plan period alongwith the number of applications received during the same period;
- (c) the reasons for less sanctions than applied for; and

# Infiltrators in Assam

### 1548. Shri D. C. Sharma: Shri P. R. Patel:

Will the Minister of Home Affairs be pleased to state:

- (a) whether a number of Pakistani deportees from Assam have reinfiltrated the State:
- (b) if so, their upto-date number; and
- (c) the steps taken to send them back and to check the reinfiltration in the State by the deportees?

The Deputy Minister in the Ministry of Home Affairs (Shri Vidya Charan Shukla): (a) Reports of re-entry into Assam of some Pak nationals deported earlier from there have been received.

- (b) During the period from 16th September 1966, 321 deported were detected on the Indo-Pak border in Assam, 24 deportees were detected in Nowgon district: Most of them were intercepted and prevented from entering Indian territory while some were arrested.
- (c) Necessary measures have been taken like intensifying patrolling on the broder, strengthening of the border posts etc.

## Pak. Infiltration on West Bengal Border

- 1549. Shri D. C. Sharma: Will the Minister of Home Affairs be pleased to state:
- (a) whether it is a fact that group of Pakistan; nationals and some persons who had years ago migrated to East Pakistan and who tried to

enter West Bengal through Bhurungamari in Cooch-Bihar towards the end of October, 1966 and have been detained by the Indian Police;

The Deputy Minister in the Ministry of Home Affairs (Shri Vidya Charan Shukila): (a) No; no such attempt by Pak nationals and other persons who had migrated to Pakistan earlier from India to enter West Bengal from Bhurungamari district Rangpur in East Pakistan opposite District Cooch-Behar in October, 1966 was made.

- (b) The Border Security Force personnel are constantly vigilant against any illegal entry into India from across the border.
