(b) whether it is a fact that surveys hae been made which proved that establishment of cement, paper, jute and wool pulp factories are economically feasible; and

(c) the steps taken by Government in order to explore these possibilities and to exploit this potential?

The Minister of Industry (Shri D. Sanjivayya): (a) to (c). The subjects relating to 'Forests' and 'Survey' are the concern of State Governments. Central Government have not received any information so far from the Government of U.P. whether any such survey has been conducted in the Tarai area. Hence he potentialities of this area are not known.
