The Deputy Minister in the Ministry of Commerce (Shri Shafi Qureshi): (a) and (b). Government had received reports about considerable accumulation of handloom stocks in the country. As a special measure to clear the accumulation. State Governments have been authorised to grant a special additional rebate of five paise in the rupee on all retail sales of handloom cloth for a period of one month at their discretion; this is in addition to the fifteen days' special additional rebate normally and wed every year. Reports just received indicate that after the special repute has been in operation for the past seventeen days, handloom stocks in Madras State are normal.

Drivers and Firemen in Chakradharpur Railway Division
